Such acts of service may go largely unnoticed and include, but are not limited to: helping senior citizens or disadvantaged persons, working to improve the quality of education, expanding recreation and cultural opportunities, working with children, protecting the environment, increasing jobs in the community, promoting public safety, and unusual acts of kindness.

What do Heart of **Jold** recipients receive?

All Heart of Gold nominees will be recognized and honored for their contribution to the community at the Heart of Gold award ceremony Saturday, Nov. 3, at the Shipshewana Event Center.

One nominee will be selected to be the Heart of Gold Award recipient and will have the opportunity to direct a \$1,000 grant to the LaGrange County charity of his or her choice from an approved list provided by LaGrange County Community Foundation.

What are the selection Criteria for Heart of Gold Awards?

When selecting the recipient, the Board of Directors will look for a nominee who:

- Identifies a need and fulfills it;
- Recognizes and acts up<mark>on opportunities;</mark>
- Shares time and ene<mark>rgy for the sake of others</mark>;
- Overcomes unusual challenges in serving others;
- Renders a service which changes lives;
- Works to cr<mark>eate positive change;</mark>
- Inspires others to volunteer;
- Performs an exceptional act of kindness.

How can I Mominate someone for the Heart of Gold Award?

To help the LCCF Board of Directors recognize your nominee's efforts, you may find the following suggestions helpful:


- State the reasons this person fits the description of having a "Heart of Gold";

- Your narrative should be suitable for a public audience and may be made available to local newspapers;
- Nominations will not be accepted from family members nor for prior recipients of this award. Nominations also will be not be accepted for groups. Only individiuals can be nominated.
