## **Homelessness in LaGrange County**

## Rebekah Brooker, Volunteer Lawyer Program of NE Indiana

Volunteer based program to meet the legal needs of residents. Also provide services on divorce, custody, power of attorney, wills, etc as well as eviction legal needs. Eviction is a prerequisite for homeless, starting eviction clinics in LaGrange County. Eviction clinics will take place in the courthouse once a month on the day of eviction hearings, an attorney will be present during those hearings. Providing free legal advice and having representation in the courthouse.

Rental assistance – helping connecting to resources, providing them at the courthouse. Looking to begin eviction clinics in June.

## Dr. Rustin Krapfl, Agape Missions of LaGrange County

Homelessness looks very different in LaGrange County. People are typically staying with friends or family until they cannot or in their vehicles. We also have professional homeless people; they don't want help they want to remain homeless. We don't have tent cities.

Agape Missions provide temporary housing and loving assistance in LaGrange County, our passion is this community. We do have people from other counties, but our passion is LaGrange County residents.

Agape Missions has two apartments, one apartment is large enough for family of 5, second apartment family can accommodate a family of 3, they are allowed to stay up to 3 months. There is an apartment upstairs that is charged rent and it supports the cost of the home.

Long-term vision is to have 5 homes throughout LaGrange County.

We have mentors that come alongside the residents, meet every week, some people are going through a lot of things. Mentors helps with jobs, budgets, hygiene, and future plans. Most residents don't have a next steps plan; they live in the moment. Most move onto the government subsided apartments in the area. We do provide spiritual care as well, the Church of God is across the street and we encourage them to attend.

Agape has provided support for 30 people this last year. Typically, we receive a call once a week. We are happy to report that 95% find stability after they leave Agape Missions. Success comes in the opportunity of someone holding them accountable.

We are limited to the number of people we can serve and are looking for additional places to house people.

People find themselves homeless for a variety of reasons, long term illness to spouse, mental illness, loss of employment, emergency, fire, drug addiction, grandparents caring for grandchildren, dealing with trauma, and some are habitual homelessness. Drug abuse is a real issue; Agape is zero tolerance for drugs, clients sign contracts and they have to be enlisted in a drug-free program in order to stay. Mentors do not provide drug abuse counseling.

Anyone that is from a domestic violence situation we refer to Elijah Haven.

We are currently looking for a home in Topeka, Wolcottville, Howe, or Shipshewana.

### Dr. William Pipher, Bloomfield Township Trustee

Township emergency assistance; 11 different townships. Trustee assistance is based on where you reside, a person can say they live in a specific township. Our designation is to help those in the township they reside, maintain basic needs.

Goal is to keep people in their homes, keeps them from being on the street and homeless. Some transients that come through. Very limited resources on short term houses. There is one hotel in Bloomfield township, can't put someone in another township. Can't make hotels take people. Available shelters in surrounding cities like Albion, Elkhart or Angola, but limited accessibility – transportation. We can help with transportation but are limited in resources. If I send them to other townships for housing, then they become a resident there.

Many families do not know what township they live in, there is a map of LaGrange County online to help.

Trustees can help with funerals.

A person can receive assistance for 2 months in a row or 3 months within a 12-month period. There is an application. We encourage people to use other resources in the community to help them so they don't have to keep coming back for assistance. Trustees are used for emergency resources not long term solutions.

## Roundtable

Christina Blaskie, Parkview LaGrange Hospital - LaGrange County Child Abuse & Neglect Collaborative. Month of April raise awareness with the blue tire at courthouse, stop child abuse in its tracks. A hashtag is used to post your picture on social media. Bonita, DCS, SCAN, Northeastern Center, Bowen Center, do a child abuse panel, we will teach how and when to report to DCS, when it's not appropriate to report there are other ways and Children First come along side with resources for financial, anger management, reduce the likelihood of child abuse to take place.
